PARTICULARS

It will be charged to their respective funding sources, such as School MOOE, Campus Journalism Funds, Local Funds, or SEF, in compliance with standard accounting and auditing procedures. (Note: 3-day meals and t-shirts will be charged to the Division Funds) Participants are strongly recommended to arrive one day prior to the RSPC proper.

- 4. A copy of the revised RSPC guidelines for the conduct of the different competitions, Parent's waiver, list of participants and Regional Memorandum No. 1314/1421 (Updates/Reminders & Logistics for the Conduct of 2025 RSPC) are enclosed with this Memorandum.
